

Dear Friend of Great Oaks,

Great Oaks (GO) is committed to creating opportunities for all students in our network through high quality schools and high dosage tutoring provided by AmeriCorps members. This approach has proven itself through research and in practice across our schools. At GO's oldest school in Newark, where the initial cohort to graduate high school will this year graduate from college; they do so at a rate that is several times that of their peers in Newark who didn't have the benefit of high dosage tutoring.

As student learning went online in the era of Covid-19, GO's AmeriCorps members were the glue that kept students connected when it was all too easy for a kid to get lost in a forest of Zoom classes. Moreover, the diverse racial & ethnic composition of the Great Oaks Fellows – more than two thirds are of color – is providing a pipeline of talent that matches the demographics of the children we serve. Finally, at a time when Americans are more divided than ever, the AmeriCorps service brings people together to build community.

As Great Oaks enters its 10th year, we have launched a \$10m initiative called **The Power of 10**, an undertaking to dramatically scale up the number of AmeriCorps tutors we deploy to support children in reaching their full human potential.

Last Spring the GO Foundation established a template for partnership through an agreement signed with the Baltimore Collegiate School for Boys. For the first time AmeriCorps Fellows recruited, trained and coordinated by the GO Foundation have been deployed at a school that was not started up by the GO Foundation. We will be seeking out more partners like this to deploy additional AmeriCorps tutors and to supplement the learning students receive in the classroom.

Given the proven effectiveness of high-dosage tutoring, we believe that every American school-aged child, regardless of their family's income, should have access to a tutor. Stay safe, we hope you and your families are well, and we are grateful for your continued support of our work.

Great Oaks Fellows prepare all students throughout the network for college success through high-dosage tutoring and mentoring. The GO Foundation led the creation of the first Great Oaks School in Newark, NJ ten years ago, followed in rapid succession by the opening of Great Oaks Schools in New York City, Bridgeport, CT and Wilmington, DE. The GO Foundation provides intensive academic, operational & finance support to GO-NYC and GO-Bridgeport and facilitates a community of practice around the deployment of Fellows throughout the network that now includes the Baltimore Collegiate and Amber charter schools.

GO Fellows play a fundamental role in supporting students in their social and emotional growth. Fellows encourage their students to have personal investment in their success and to build an understanding that they have control over their lives. Fellows help empower our students to evolve into leaders.



The GO Fellowship, with its intense focus on individualized small group instruction, changes educational outcomes for students. In partnership with high quality classroom teaching, Fellows are more than tutors and mentors, they are a key part of the glue that makes the school experience cohesive for students and their families.

In 2019, GO partnered with Columbia University to conduct a qualitative study and longitudinal impact evaluation to understand how the GO Model drives student outcomes. This partnership also includes constructing a measurement framework and set of tools that will allow us to continue meeting students' academic and social-emotional needs.



Ms. Maria Hurley, a teacher at GO-NYC, leads instruction at a time that has presented educators with an unprecedented array of physical, cultural, political, and technological challenges. In response Covid-19, GO schools shifted to virtual and hybrid instruction while ensuring students received consistent access to rigorous coursework, small group advisory, and support from caring adults.

Great Oaks schools engage students as active participants in shaping their own learning. This year at GO-NYC, students invite their family members and educators together for quarterly student-led conferences where they discuss their own academic progress and ways they can improve as a learner and develop as a leader at school.



Latoya Hubbard joined GO-Bridgeport in 2018 as the Director of Operations and leads a dynamic team. In response to Covid-19 and the shift to remote and hybrid instruction in 2020, GO-Bridgeport quickly ensured a strong plan for all 660 students to access a personal laptop and the Internet, virtual learning platforms, safe classroom environments, and reliable meal distribution.

GO Fellows are provided housing in proximity to their schools, which helps cultivate and strengthen a supportive community. In December 2019, Fellows at GO-Bridgeport moved into newly constructed apartments adjacent to the school building and part of the Cherry Street development in Bridgeport's West End.

GO Fellows played a vital role in her success: "Fellows brought the school together. They built strong connections with students, and our unit became a family because I trusted them. Issues of race and class, equity and inclusion are critical lenses through which our schools monitor progress, develop curriculum and pedagogy, and cultivate culture and community. GO Fellows have the opportunity to work towards teaching certification through the GO Teacher Residency Program and partnerships with Relay and NYU Steinhardt School of Education. The Program addresses critical teacher shortages in our school communities by building a pipeline of talented educators from diverse backgrounds who enhance the quality of teaching and learning across all grades.
